# Wetlands: YOUR LEGAL RESPONSIBILITIES

In Australia and around the world, wetlands are now recognised as some of our most valuable ecosystems. They are a distinctive part of Victoria's Western District and are protected by legislation.

### How are wetlands protected by law?

It is an offence to damage or destroy wetlands under Local, State and Federal Government laws. These laws exist to protect wetlands, their water assets and natural features, and the native species which reside in them. The type of wetland and its significance will determine the level of protection.

#### Local and State legislation protecting wetlands:

#### Threats to wetlands

Some of our wetland systems are no longer working naturally because human activity has changed the way water flows in or out of them. They are often threatened by a lack of water, physical change from development, pollution, and poor or uninformed land management decisions.

DAMAGING A WETLAND CAN RESULT IN FINES UP TO \$150,000 AND A REQUIREMENT TO REINSTATE THE IMPACTED AREA.

- × CROPPING A WETLAND
- × DRAINING AND/OR EXTRACTING WATER
- × PHYSICALLY CHANGING A WETLAND WITH MACHINERY
- × DUMPING WASTE MATERIAL
- × DIVERTING ADDITIONAL WATER INTO A WETLAND

### HOW TO AVOID BREAKING THE LAW


Do not undertake any work in an area which may be a wetland until you have checked all the details!

# Wetlands: ARE PROTECTED BY LAW

- · Seasonal herbaceous wetlands are critically endangered
- · International agreements exist to protect wetlands and the migratory birds which use them
- · Diverting additional water into a wetland can be just as detrimental as draining water out of a wetland
- · Wetlands are protected by the same range of legislation that protects remnant vegetation and native forests
- · Wetlands are protected for their natural, environmental and cultural values
